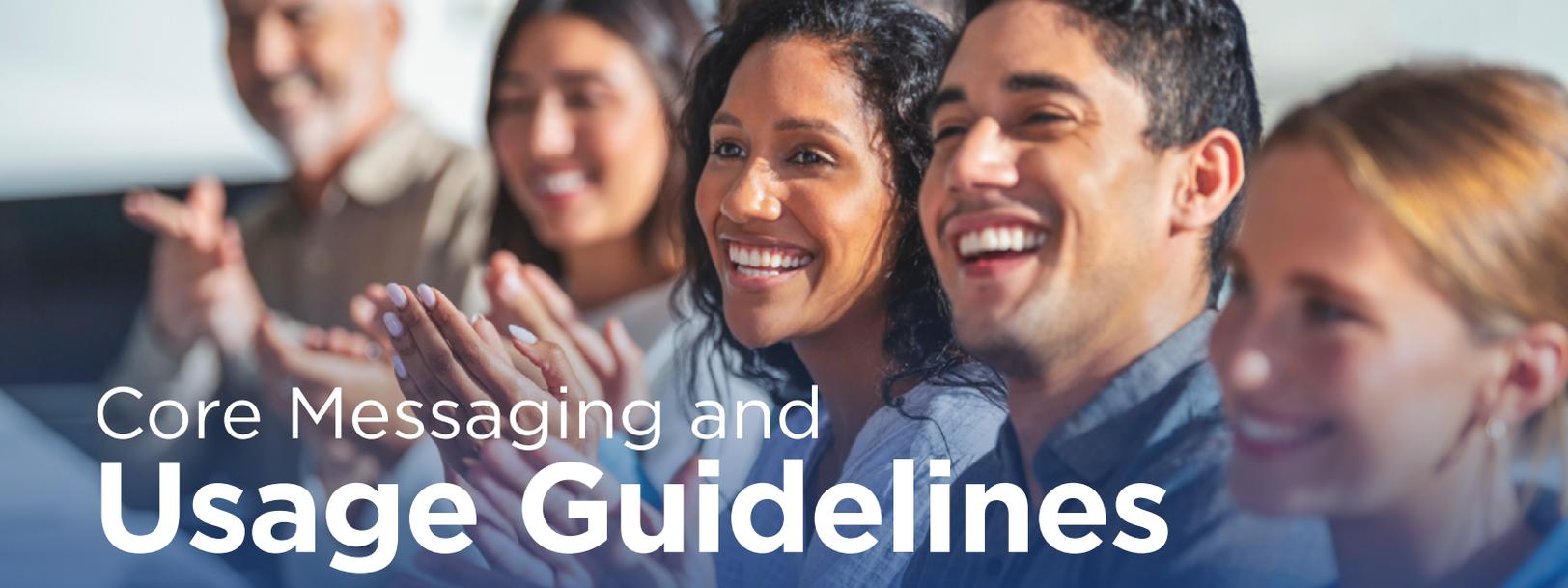
## Organizational Overview

# Brand Dos and Don'ts

- Do not refer to Colorado Access as anything besides “Colorado Access” in a post. Specifically, do not use Colo Access, Co Access, or COA.
- Do use “health care” instead of “healthcare” if it does not conflict with your style guide.
- Per the Department of Health Care Policy & Financing (HCPF) guidelines, do refer to:
  - Health First Colorado as “Health First Colorado (Colorado’s Medicaid program) on first reference
  - CHP+ as “Child Health Plan *Plus* (CHP+)” on first reference with the “Plus” italicized. We understand this is not always possible on social media channels, but this is the proper name.

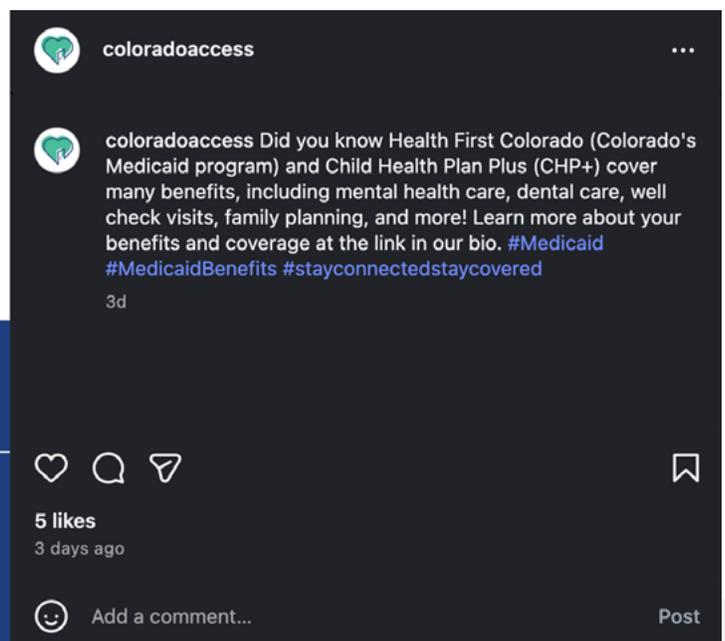
